**Senior Dog Rescue, Foster Care, and Adoption:**

**In 2014 Muttville rescued 780 senior dogs from municipal shelters, a 45% increase over 2013. The secret to Muttville's success is its foster care network, allowing rescued dogs to be housed in home settings rather than in kennel conditions. Not only is a home environment more humane and less stressful for the rescued animals, but foster families carefully monitor the dogs to learn about their behavior, health, training, and temperament.**

**This invaluable information is passed along to potential adopters, meaning Muttville is able to make informed adoption matches, resulting in a high percentage of successful first-time adoptions.**

**Our Seniors for Seniors program has two principal elements: (1) Cuddle Club, our twice monthly get-togethers. Cuddle Clubs creates community for senior citizens and opportunities for getting lots of love from the dogs and humans alike. Also, we waive adoption fees for senior citizen guardians and send them home with a kit (including beds, bowls, leashes, harnesses, medications, and food needed for the first month) for their new dog.**
