THEY COME PRIMARILY FROM SHELTERS WHERE THEY ARE FACING IMMINENT EUTHANASIA. MUTTVILLE HAS ITS OWN CAGE-FREE FACILITY FOR NEW ARRIVALS, WHO UNDERGO MEDICAL TREATMENT AND ARE MATCHED AS SOON AS POSSIBLE WITH LOVING FOSTER HOMES. FOSTER CARE ALLOWS THE DOGS TO LIVE IN COMFORTABLE HOME SETTINGS AS THEY AWAIT ADOPTION. FOSTER FAMILIES GET TO KNOW THE DOG IN A HOME SETTING WHICH ENABLES THEM TO PROVIDE DEEP INFORMATION THAT ENABLES MUTTVILLE TO MAKE INFORMED MATCHES WITH NEW FOREVER FAMILIES. THIS RESULTS IN A HIGH PERCENTAGE OF SUCCESSFUL FIRST-TIME ADOPTIONS. DURING THE PANDEMIC, WHEN THE CITY MANDATED ALL SHELTERS TO BE CLOSED,
